CA	<b>Convictions</b> can only be reported back <b>7 years</b> , based on the disposition date. <b>Non-Convictions</b> cannot be reported at all regardless of age, except for pending charges.
CO	<b>Convictions</b> can only be reported back <b>7 years</b> , based on the disposition date. <b>Non-Convictions</b> can only be reported back <b>7 years</b> , based on the arrest date.  *Salary Exemption – If the salary is expected to be \$75,000 or more, the 7-year exemptions do not apply.
TX	<b>Convictions</b> can only be reported back <b>7 years</b> , based on the disposition date. <b>Non-Convictions</b> can only be reported back <b>7 years</b> , based on the arrest date.  *Salary Exemption – If the salary is expected to be \$75,000 or more, the 7-year exemptions do not apply. Convictions can only be reported back to age 18.
KS, MD, NH, WA	<b>Convictions &amp; Non-Convictions</b> can only be reported back <b>7 years</b> , based on the arrest date.  *Salary Exemption – If the salary is expected to be \$20,000 or more, the 7-year exemptions do not apply.
NM	<b>Convictions</b> can only be reported back <b>7 years</b> from the date of release or parole. <b>Non-Convictions</b> cannot be reported except pending trial.
MT	<b>Convictions</b> can only be reported back <b>7 years</b> , based on the disposition date. <b>Non-Convictions</b> can only be reported back <b>7 years</b> , based on the arrest date.
KY	<b>Non-Convictions</b> cannot be reported, regardless of age.
AR	<b>Convictions:</b> Felonies can be reported back <b>10 years</b> ; Misdemeanors back <b>5 years</b>
MA	<b>Convictions</b> can only be reported back <b>7 years</b> from the date of disposition, release, or parole. <b>Non-Convictions</b> can only be reported back <b>7 years</b> , based on the arrest date.
NY	<b>Convictions</b> can only be reported back <b>7 years</b> , based on the disposition date. <b>Non-Convictions</b> cannot be reported at all regardless of age, except for pending charges.  *Salary Exemption – If the salary is expected to be \$25,000 or more, the 7-year exemptions do not apply.
